The undersigned, for himself or herself, and his or her spouse, children, legal representatives, heirs, and assigns, does hereby release, remise, and forever discharge MVRRA, its officers, directors, agents, operators, shareholders, insurers, indemnitors, successors, assigns, affiliated or related corporations, partnerships, and companies, and any owner or lessee of railroad equipment or facilities located upon MVRRA property, of and from any and all claims, demands, rights, causes of action, actions, suits, proceedings, damages, expenses, losses, compensation, judgments, executions, liabilities, and obligations of any nature whatsoever on account of injury to the undersigned's person or property resulting from or related to the undersigned's presence upon MVRRA property, including injury resulting in death of the undersigned, whether caused by the actual or alleged negligence or other fault or wrongful conduct of MVRRA/TCW or otherwise. The undersigned expressly acknowledges that he or she knowingly and voluntarily assumes all risks of injury to person or property while on MVRRA property.
